**DIRECTIONS TO HOTEL & MAIN SHOW SITE**

**Driving:** Follow the trail from your house to Portland, Oregon.- Vancouver Washington. The two towns are on either side of the Columbia River. The host hotel is on the river right by the Interstate Bridge (Interstate I-5) that connects the two cities.

**From Seattle:** I-5 South to Vancouver. Take Mill Plain Blvd. Exit #1C towards City Center. Keep right at the fork in the ramp. Merge onto 15th Street. Turn left onto W. Washington Street. Turn right onto W. 3rd Street. Turn left onto W. Columbia Street. to site.

**From Portland:** I-5 North to Vancouver. Take the 6th Street Exit #1B towards City Center. Merge onto 6th Street. Turn left onto W. Washington Street. Turn right onto W. 3rd Street. Turn left onto W. Columbia Street to site.

**From Portland International Airport:** From airport take I-205 North to Vancouver. Take the WA-14 Exit #27 onto WA-14 West. Take the City Center Exit and merge onto 6th Street and follow directions from 6th Street from the Portland directions above.

**Flying:** Fly into Portland International Airport and take the shuttle to the hotel.

Directions from Show Site: Exit Hotel parking lot turning left on to Columbia Street going toward W 3<sup>rd</sup> Street. Go .7 miles. Turn RIGHT onto Mill Plain Blvd. - go .5 miles. Turn LEFT onto I-5 North toward Seattle - go .9 miles. Take Exit #2 onto WA-500 East toward Orchards - go 2.8 miles. Take ramp toward NE Andresen Rd. - .5 miles. Turn RIGHT on NE Andresen Rd. - go .2 miles. Turn RIGHT on NE Fourth Plain Blvd. - go .1 mile. Arrive at Emergency Veterinary Services on the left.

Exit #9 Battleground (179th Avenue/Clark County Fairgrounds). Go East toward Battleground on 179th Street. Past 72 <sup>nd</sup> Avenue (signal light & John Deere store on left) (about 3 miles). Right on 92 <sup>nd</sup> Avenue (about a mile further). 92 <sup>nd</sup> Avenue curves to left and becomes 156 <sup>th</sup> Street. Left into driveway just before row of trees on left and before sign for Dairy Farm. Parking for events is at 9628 NE 156 <sup>th</sup> Street.
